3. Support Committee Treasurer: Marilyn Peck will continue as Support Committee treasurer.
4. Pavilion Cleaning: Marilyn Peck will continue to be in charge of the Pavilion cleaning.
5. Pavilion Walls: George Heinz, Roy Gurr, Bob DeRegnaucourt and others will put the Pavilion walls in 15 Oct 98.
6. South exhaust fan: is not functioning and ? is to call John Stoker for help. He is a Stetson square.
7. Pavilion Supplies: Jean and Bob DeRegnaucourt will purchase supplies for the pavilion as requested by Marilyn Peck.
8. Cabinets: Folk dancers will move the cabinet under the south window to the north window and then give up their kitchen cabinet to another club. They

will install a lock on it. Committee should find out who has each cabinet in the building.

9. Support Committee Funds: Committee discussed placing support funds in some type of interest bearing account, money market which was rejected, CD which was approved, preferably tax exempt. Will try and use MVDC's tax exempt status. Care needs to be taken that funds do not get co-mingled with MVDC's funds.
